### **Town of Pike Road Sales Tax Rate Adjustment Effective October 1, 2026**

Dear Citizens and Business Owners,

The Town of Pike Road would like to inform residents, visitors, and business owners that, effective October 1, 2026, the local sales tax rate within the Town will be 10% and the PJ rate will be 8.25%.

This adjustment aligns Pike Road's sales tax rate with that of many surrounding communities and creates greater consistency for consumers and businesses throughout the region. By leveling the sales tax rate, the Town aims to provide continuity in purchasing transactions while simplifying tax administration and improving overall efficiency.

Revenue generated through this adjustment will help support and maintain essential services that directly benefit our community, including:

- Road construction and maintenance
- Educational initiatives and community partnerships
- Public Safety services like our Volunteer Fire Department operations and equipment
- Community engagement activities and events
